



TERMS AND CONDITIONS OF THE “FREE YEAR OF INTERNET SERVICE” PROMOTIONAL OFFER FOR T-MOBILE PREPAID USERS IN THE GO! TARIFF

1. Basic information about the offer

- You can benefit from these promotional terms and conditions in a period from 01.07.2022 to 30.09.2022 or until they are withdrawn by T-Mobile Polska S.A.
- The terms and conditions apply to the GO! tariff in the T-Mobile prepaid system and to customers using the Frii – Blueconnect prepaid Internet tariff who switch their tariff to GO!

2. What do you get?

- We offer you a bonus of 1200 GB (hereinafter referred to as the “Bonus”) as part of the “Free year of Internet service” offer (hereinafter referred to as the “Offer”)
- As part of the Bonus, you have the opportunity to use up to 12 data transfer packets of 100 GB each, hereinafter referred to as the “Packages”.

3. How to activate it?

- You can order activation of the Bonus in My T-Mobile [Mój T-Mobile] app.

4. How does it work?

- 4.1. In order to be granted the Packages, you must have the following features active in your account:
 - 4.1.1. one of the variants of the “No Limit L”, „No Limit L^{+UA}” or „No Limit XL” cyclical offer available under the Terms and Conditions of the “No Limits” Promotional Offer, and
 - 4.1.2. “Free year of Internet service” offer
- 4.2. Addition of the first 100GB Package as part of the Bonus:
 - 4.2.1. will take place immediately after activation of the Offer, no later than within 24 hours, and will be confirmed by a text message,
 - 4.2.2. results in setting of the validity period for the entire Bonus to 365 full calendar days (this is a fixed and total period of time during which you can use all of the Packages granted to you under the Bonus).
- 4.3. Addition of each subsequent (max. 11) Packages:
 - 4.3.1. will not change the Bonus validity period which was set upon activation of the first Package (as per the rule in item 4.2.2.),
 - 4.3.2. will take place on the renewal date of one of the variants of the “No Limit L”, “No Limit L^{+UA}” or “No Limit XL” cyclical offer active in your account.
- 4.4. If your “No Limit L”, “No Limit L^{+UA}” or “No Limit XL” offer is suspended, the addition of the subsequent Package will also be suspended for a maximum period of 90 days. During this period, you will be able to use the GBs previously accumulated under the Bonus, but the total time during which the subsequent Packages are available to you will not change (as per the rule in item 4.2.2.).
- 4.5. If during said 90-day period the variant of your “No Limit” offer is unsuspended, you will be granted another Package under the Bonus, no later than within 24 hours, which will be confirmed by a text message
- 4.6. If the option of your “No Limit” offer is deactivated (including automatically, 90 days after suspension) or if the variant is changed to “No Limit M” or “No Limit S” option, the Offer will be deactivated (no subsequent Packages will be granted) and unused units under the Packages will be automatically cancelled. After this time, the Offer will be available after re-activation, provided that we continue to offer it.
- 4.7. You can only have one Bonus active at a time.
- 4.8. A switch between variants of the “No Limit L”, “No Limit L^{+UA}” or “No Limit XL” offers:
 - 4.8.1. does not result in deactivation of the Offer,
 - 4.8.2. entitles you to use the remaining GBs accumulated under the Offer,
 - 4.8.3. adds another Package granted as part of the Bonus,
 - 4.8.4. does not change the Bonus validity period which was set upon activation of the first Package.
- 4.9. Unused units under a Package are added to subsequent Packages granted under the Bonus.
- 4.10. You can use the Bonus if your account is active for outgoing calls.

5. How to check the status?

- As part of the promotion, you may be notified by a text message about:
 - deactivation of the Bonus,
 - granting of the Packages,
 - inability to activate the Bonus when you do not have an active “No Limit L”, “No Limit L^{+UA}” or “No Limit XL” offer or if the offer is in the “suspended” status,
 - an upcoming date of adding a subsequent Package and the need to renew the “No Limit” offer,
 - upcoming expiry of the Bonus validity period and the available offer for data transfer,
 - suspension of a Package addition due to the suspension of the “No Limit” offer,
 - usage of the Bonus,
 - expiry of the Bonus validity period.

6. Important information

- 6.1. Data that is not used during the Bonus validity period is automatically deleted.
- 6.2. If the entire Bonus is used before expiry of its validity period, the data transfer fees will be charged in accordance with the terms and conditions of the offer you are currently using.
- 6.3. The Bonus shall be used first, before the accumulated amount in PLN and other data resources available in the account, including the "GB on top-up" [GB po doładowaniu], "No Limits" [Bez limitów], "GB one-time" [GB na raz], "GB one-time in the app" [GB na raz w aplikacji], "GB round-the-clock" [GB na okrągło], unless the provisions of other offers expressly stipulate otherwise. Units from the "Bonus for switching the tariff to GO!" offer are used first.
- 6.4. Changing the tariff within the T-Mobile prepaid system and migration to the Mix and Heyah prepaid systems or to a subscription system results in the automatic deactivation of the Bonus. Unused units are lost.
- 6.5. The use of these terms and conditions does not affect the EU Data Limit referred to in the price list of the GO! tariff in the T-Mobile prepaid system.
- 6.6. You will not receive a Package if the variant of your “No Limit” offer is suspended or deactivated.
- 6.7. If you are a User of the Frii – Blueconnect prepaid Internet tariff, you may use these promotional terms and conditions provided that you switch your current tariff to the GO! tariff in the T-Mobile prepaid system in accordance with the Terms and Conditions of the “No Limits” Promotional Offer for T-Mobile prepaid users or the Terms and Conditions of the “Switching the tariff to GO!” Promotional Offer for T-Mobile prepaid users.

7. Final provisions

- 7.1. The service allows mobile Internet access as part of the packet data transfer, which is implemented in all mobile technologies that are currently available and used by us. An indicative map of the Network coverage and information about the technologies used are available at www.t-mobile.pl.
- 7.2. Matters that are not regulated herein shall be governed by the Terms and Conditions of the “No Limits” Promotional Offer and the Price List of the GO! tariff in the T-Mobile prepaid system and by the “Rules for the Provision of Telecommunications Services in the T-Mobile prepaid system”, available at www.t-mobile.pl.
- 7.3. We may terminate the provision of services under this promotional offer or change its terms and conditions at any time. This means that you will be able to use the services under this offer until the last day of their validity provided for in the promotional terms and conditions. Once the offer has ended, you will not be able to reactivate it.
